



## 2021 - EYE Opening IPO Facts

Best wishes for a Wealthy and Prospective 2022 from Team PRSSB!

In this edition of the newsletter, we bring **EYE-Opening Facts of IPOs of 2021**

- The Total Amount raised via IPOs in 2021 (Rs 1.19 Trillion) is **1.5 Times the Govt of India's Health and Family Welfare Budget.**
- Roughly **2/3rd of the money raised in IPO was via OFS (Offer for Sale)** depicting that nearing 66% of the money was received by Promoters/Venture Capitalists/Pvt Equity Firms, **implying that the money never came on the Books of the company.**
- **20 companies of the 63 companies that came up with an IPO did a 100% Offer for Sale** which includes the likes of CarTrade, Sapphire Foods, Clean Science & Technology, MapMyIndia, Nazara Technologies and Easy Trip Planners - this money gave an exit to the existing shareholders.
- Of the nearly Rs 1.19 Trillion raised via IPOs, nearly **40% of the money was raised by only 5 companies** - Paytm, Zomato, Star Health & Allied, PolicyBazaar and Sona BLW Precision
- The **largest IPO of 2021 was Paytm (Rs 18300 Cr)** and the **Smallest IPO of 2021 was Nureca Ltd (Rs 100 Cr)**
